### How your new clients qualify

Customers just need to confirm that they meet our simple, health-related eligibility criteria when they take out a new Healthier Solutions policy. For policies covering only one adult, we will apply up to 15% discount to the policy if this adult meets the eligibility criteria.

For policies covering more than one adult, both adults must satisfy the eligibility criteria to achieve up to 15% policy discount. If only one of them satisfies the eligibility criteria, we will apply up to 7.5% discount to the policy.

# My Healthy Discount terms and conditions

## 1 Eligibility conditions

To be eligible for My Healthy Discount, customers must satisfy the following health criteria:

By accepting a My Healthy Discount incentive, you confirm that:

- You have not smoked tobacco, used e-cigarettes, vaping products, or any other nicotine replacement products within the last 12 months;
- Your Body Mass Index is not greater than 30;
- and You are not currently diagnosed as diabetic or pre-diabetic and have not had treatment or medication for diabetes or pre-diabetes in the last 12 months.

Failure to satisfy the eligibility criteria when accepting the My Healthy Discount incentive may lead to future claims being denied.

If the customer does not meet the My Healthy Discount criteria, the discount will not apply.

Child dependant members are not required to satisfy the eligibility criteria but will benefit from the policy level discount.

## 2 Offer dates

This offer is available for customers purchasing a Healthier Solutions policy with a start date between 1 May 2024 and 31 December 2024. Aviva reserves the right to withdraw this offer before 31 December 2024 or extend the offer beyond that date.
