The total amount payable would be **£868,388.63** made up of the loan amount plus interest (**£533,643.63**) and Valuation Fee (**£375**), CHAPS Fee (**£25**), Application Fee (**£125**), Arrangement Fee (**£499**) and Discharge Fee (**£125**).
