- Pension timings apply to cases authorised by New Business on the cut off day stated.
- Pension charges will generate on the next policy anniversary date.
- Where a statement due day falls on Saturday or Sunday, the cut off days are those applicable to a statement due on a Monday. The actual statement will be issued on the Monday (or the next working day in the event of Bank Holidays).
- The above cut-off days are assuming no system failures occur, causing delays to batch processing.
- Protection policies will not generate commission until 90 days before the start date of the policy.
